

Competition Terms & Conditions

Daai Plekkie in die Weskus – Women's Day Weekend Away Competition

Competition Period: 4 August 2026 – 10 August 2026

This Competition is brought to you by Daai Plekkie in die Weskus (Pty) Ltd ("Daai Plekkie") and is offered subject to the terms and conditions set out below.

Participation by entrants in the Competition constitutes an agreement to abide by all these terms and conditions. Daai Plekkie reserves the right to disqualify any entrant who breaches any provision(s) hereof.

1. COMPETITION OVERVIEW

Buy a Brutal Fruit at the Daai Plekkie restaurant between 4 and 10 August 2026 and stand a chance to win a 2-night weekend getaway for 2 (two), including meals, drinks and a couples spa experience.

2. COMPETITION PERIOD

2.1 The Competition runs from 4 August 2026 and ends 10 August 2026. Brutal Fruit sales during restaurant hours only, from when legal alcohol sales open. (the "Competition Period").

2.2 Entries received outside the Competition Period will not be considered.

3. ELIGIBILITY

3.1 Entrants must be 18 (eighteen) years or older.

3.2 Entrants must make a Qualifying Purchase (as defined below) at Daai Plekkie during the Competition Period.

3.3 Employees and directors of Daai Plekkie in die Weskus (Pty) Ltd and their immediate family members, may not enter this Competition.

3.4 Where the eligibility criteria cannot be confirmed, Daai Plekkie reserves the right to disqualify the entrant and award the Prize to an alternative entrant.

4. HOW TO ENTER

4.1 Buy a Brutal Fruit at the Daai Plekkie restaurant during the Competition Period (a "Qualifying Purchase").

4.2 Write your full name and contact number, in legible handwriting, on the entry slip (Your bill) for every Qualifying Purchase. In the case of more than one beverage being on a single slip, the staff will assist ensuring your multiple entries are received.

4.3 Place your completed entry slip in the entry box at Daai Plekkie.

4.4 Multiple entries are permitted — one valid entry slip per Qualifying Purchase.

4.5 Incomplete, illegible or duplicate entry slips may be disqualified.

5. THE PRIZE

5.1 There is 1 (one) prize available (the "Prize"), consisting of the following:

5.1.1 A 2 (two) night stay for 2 (two) people at the Plekkie Boutique Hotel. Should the Plekkie Boutique Hotel not be available for the winner's requested dates, Daai Plekkie reserves the right to substitute the stay with one of its other three properties.

5.1.2 Friday: Dinner.

5.1.3 Saturday: Breakfast buffet, lunch and dinner.

5.1.4 Sunday: Breakfast buffet, followed by check-out.

5.1.5 A choice, for each qualifying meal, of 300g Rump Steak, Calamari Tubes & Tentacles, or Chicken Schnitzel, finished with the Baked Cheesecake drizzled with Hanepoot Syrup.

Should any of these dishes not be available, Daai Plekkie will substitute an alternative dish or dessert of equivalent value.

5.1.6 One drink per person, per meal listed above (draught beer, house wine or a soft drink).

5.1.7 A 4–5 hour couples spa experience at La Vita, Mykonos, Langebaan.

5.2 The accommodation and dining portion of the Prize is redeemable during the following periods only:

5.2.1 11 August – 30 November 2026

5.2.2 1 May 2027 – 30 September 2027

5.3 Redemption is subject to availability and advance booking, and Daai Plekkie does not guarantee availability on any specific date within these periods.

5.4 The spa voucher is valid for 36 (thirty-six) months from date of issue and does not need to be used together with, or during, the accommodation stay. The winner is responsible for coordinating their preferred spa booking date directly with La Vita, Mykonos, and for ensuring their chosen dates align with the availability of both the accommodation stay and the spa.

5.5 Transport to and from Daai Plekkie, the Plekkie Boutique Hotel (or substitute property) and La Vita, Mykonos, as well as any transport required during the stay, is not included in the Prize and remains the winner's sole responsibility.

5.6 The Prize is not transferable, exchangeable or redeemable for cash, in whole or in part, and may not be on-sold.

5.7 Should any element of the Prize become unavailable for reasons beyond Daai Plekkie's control, Daai Plekkie reserves the right to replace it with an alternative of similar value.

5.8 If Daai Plekkie discovers, whether before or after the Prize has been awarded, that a winner was ineligible to enter or to win, Daai Plekkie may, at its discretion and without prejudice to any other remedy:

5.8.1 where the Prize has not yet been awarded, withhold the Prize and award it to an alternative entrant;

5.8.2 where the Prize has been awarded but not yet used, redeemed, or collected, require the winner to return the Prize or any unused or unredeemed portion of it; or

5.8.3 where the Prize has already been used, redeemed, or collected such that return is not possible, require the winner to repay the monetary value of the Prize to Daai Plekkie.

5.9 This clause does not obligate Daai Plekkie to pursue recovery in every instance; Daai Plekkie may, at its sole discretion, elect not to enforce the above.

5.10 Daai Plekkie accepts no liability for entries that are lost, late, corrupted, or not received due to technical issues.

6. THE DRAW

The draw will take place on or about 11 August 2026, using an AI-assisted random computerised selection process, alternatively a manual draw conducted by Daai Plekkie management, from all valid entries received during the Competition Period.

7. WINNER NOTIFICATION

7.1 Daai Plekkie will attempt to contact the winner telephonically, on the contact number provided on the winning entry slip, from 11 August 2026.

7.2 If the winner cannot be reached telephonically within 48 (forty-eight) hours of the first attempt, Daai Plekkie will use reasonable endeavours to make contact via WhatsApp and/or SMS.

7.3 If the winner has not been reached within 48 (forty-eight) hours of the first attempted contact, the Prize will be forfeited and Daai Plekkie reserves the right to conduct a re-draw and select an alternative winner.

- 7.4 By entering, entrants consent to being contacted telephonically and via WhatsApp and/or SMS for purposes of administering this Competition.
- 7.5 The winner may not announce or claim publicly or privately that they are a winner until Daai Plekkie has formally announced the winner. Daai Plekkie takes no responsibility for any embarrassment or inconvenience caused by premature announcements.

8. PRIZE COLLECTION AND REDEMPTION

- 8.1 The winner must produce valid identification matching the details on the winning entry slip before any Prize will be awarded.
- 8.2 The winner must contact Daai Plekkie directly to arrange their preferred accommodation dates, subject to the redemption windows and availability set out above, and must contact La Vita, Mykonos directly to arrange their spa booking.
- 8.3 Daai Plekkie accepts no responsibility where the winner fails to book within the applicable redemption period or voucher validity period, and the Prize (or the relevant portion of it) will be forfeited without compensation in such circumstances.

9. GENERAL

- 9.1 These terms and conditions are governed by the laws of the Republic of South Africa.
- 9.2 By entering this competition, entrants confirm that they have read, understood, and agree to be bound by these terms and conditions.
- 9.3 Daai Plekkie reserves the right to amend these terms and conditions at any time.
- 9.4 Daai Plekkie reserves the right to cancel, suspend or terminate the Competition at any time without notice. In the event of any dispute, Daai Plekkie's decision is final and binding, and no correspondence will be entered into.

10. LIABILITY

- 10.1 To the maximum extent permitted by law, Daai Plekkie and its holding, subsidiary, associated, and interrelated companies, directors, officers, employees and agents, shall not incur any liability for any injury, loss, claim, damage, or death of any nature whatsoever suffered by the winner (whether direct, indirect, or consequential) arising from:
- 10.1.1 Participation in this Competition;
 - 10.1.2 Acceptance or use of the Prize; or
 - 10.1.3 Participation in any activities in connection with this Competition, which is entirely at the winner's own risk.
- 10.2 In the event of Force Majeure (including but not limited to acts of God, strike, war, riot, fire, accident, governmental restrictions, pandemics, or any circumstances beyond the reasonable control of Daai Plekkie), Daai Plekkie shall be relieved of all obligations to the winner during the period such Force Majeure continues and shall not be liable for any delay, failure, or loss suffered.

11. PROTECTION OF PERSONAL INFORMATION

- 11.1 Daai Plekkie collects entrants' and the winner's personal information solely to conduct this Competition and to administer the Prize. If the requested information is not provided, the entrant may not participate.
- 11.2 Daai Plekkie will not disclose this information to any third party, other than contractors providing services in relation to this Competition, unless compelled or permitted to do so by law.

By entering, entrants agree to receive further communication and direct marketing from Daai Plekkie, and may opt out of such communications at any time via the opt-out mechanisms provided.
- 11.4 This Competition complies with the Consumer Protection Act, 68 of 2008 ("CPA") and the Protection of Personal Information Act, 4 of 2013 ("POPIA"). In the event of any conflict
